THE NEED...

When you're a child, safety is everything. And safety should start within the walls of your own home and the arms of your family members and loved ones.

Yet for at least 1 in 7 children across the United States, that is not the reality. Instead, these children face the awful impacts of abuse in various forms, from physical and sexual to emotional and neglect – most often at the hands of a family member, known person, trusted adult, or authority figure.

Child abuse and neglect are complicated forms of trauma, as many children don't fully understand what is happening to them, or why. When they suffer abuse at the hands of a trusted adult, the complex emotions are compounded by the manipulation they experience, such as through:

- receiving special treatment, attention, or gifts
- feeling pressured to not get the perpetrator in trouble (underlying devotion, despite the abuse)
- blackmail (especially with teenagers and the darker side of the internet)
- fear and embarrassment
- not being able to articulate what is happening to them and the wrongness of it (some children aren't old enough yet to speak)

With Snapchat, TikTok, and other applications and websites on the rise, it's easier than ever for perpetrators to take advantage of minors. With the ever-changing risk increasing, the need for our holistic, childfriendly programs at Strength and Mending Child Advocacy Center has never been greater. THE HEART OF S.a.M. CAC

In the majority of child abuse cases, there is no physical evidence. In fact, it is estimated that 98% of cases lack physical evidence. That adds even more importance to the coordinated, multidisciplinary approach and response.

That's why obstacles don't stop us from continuing to help survivors heal, process their experiences, and emerge from their trauma stronger than ever before. Each child and family that walks through our doors, motivate us to serve more children and families in the future. It's ultimately the children we serve who inspire us to continue in this often painful, hard work. Because they are the future. They are resilient, courageous, and worthy. Their voices matter and they deserve to be heard. And when life throws awful, confusing, and unfair circumstances at them, they need a team of support to help them navigate the path toward healing, understanding, and freedom.
